I. Situation Overview

On 08 July 2024 at around 4:06 AM, a fire incident occurred in Brgy. Gua-an, Leganes, Iloilo City. The fire was declared out at around 5:00 AM.

A total of **six (6) families** or **17 persons** were affected in **Brgy Gua-an, Leganes, Iloilo** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **six (6) families** or **17 persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

A total of **four (4) houses** were **totally damaged** in **Brgy Gua-an**, **Leganes**, **lloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱52,506.00 worth of assistance was provided to the affected families; of which, ₱46,506.00 from DSWD and ₱6,000.00 from the Local Government Unit (LGU) (see Annex D).
