I. Situation Overview

On 13 August 2024 at around 7:30 AM, a fire incident occurred in Brgy. Inabasan, Maasin, Iloilo. The fire was declared out at around 8:15 AM.

One (1) house was **totally damaged** in **Brgy. Inabasan, Maasin, Iloilo** (see Annex C).

A total of **₱7,964.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
