I. Situation Overview

On 05 July 2024 at around 9:45 AM, a fire incident in Brgy. Libas, Roxas City, Capiz. The fire was declared out at around 10:30 AM.

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **four (4) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Libas, Roxas City, Capiz (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱12,919.00 worth of assistance was provided to the affected family; of which, ₱7,919.00 from DSWD and ₱5,000.00 from the Local Government Unit (LGU) (see Annex D).
