I. Situation Overview

On 05 July 2024 at around 9:45 AM, a fire incident in Brgy. Libas, Roxas City, Capiz. The fire was declared out at around 10:30 AM.

Outside Evacuation Center

One (1) family or four (4) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Libas, Roxas City, Capiz** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱12,919.00** worth of assistance was provided to the affected family; of which, **₱7,919.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
