

DSWD DROMIC Report on the Fire Incident in Brgy. Lumaynay, Altavas, Aklan

13 August 2024, 6AM

I. Situation Overview

On 18 July 2024 at around 5:30 PM, a fire incident occurred at Brgy. Lumaynay, Altavas, Aklan. The fire was declared out at around 6:30 PM.

In response, the DSWD through its Field Office in Region VI, provided relief assistance to support the immediate needs of the affected family.

One (1) family or six (6) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Lumaynay, Altavas, Aklan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱6,735.44** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
