





DSWD DROMIC Report on the Fire Incident in Brgy. Malama, Conner, Apayao

27 August 2024, 6PM

I. Situation Overview

On 15 June 2024 at around 8:00 PM, a fire incident occurred at Purok 7, Brgy. Malama, Conner, Apayao. The fire was declared out at around 9:00 PM.

II. Status of Affected Areas and Population

Two (2) families or six (6) persons were affected in Brgy. Malama, Conner, Apayao (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

Two (2) families or six (6) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One house was totally damaged in Brgy. Malama, Conner, Apayao (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱89,137.90 worth of assistance was provided to the affected families; of which, ₱39,137.90 from DSWD and ₱50,000.00 from the Local Government Unit (LGU) (see Annex D).
