## **DSWD DROMIC Report on the Fire Incident in Brgy. Mapili, San Enrique, Iloilo**

28 August 2024, 6AM

### **I. Situation Overview**

On 08 August 2024 at around 8:00 AM, a fire incident occurred in Brgy. Mapili, San Enrique, Iloilo. The fire was declared out at around 9:10 AM.
