28 August 2024, 6AM

I. Situation Overview

On 08 August 2024 at around 8:00 AM, a fire incident occurred in Brgy. Mapili, San Enrique, Iloilo. The fire was declared out at around 9:10 AM.

One (1) house was totally damaged in Brgy. Mapili, San Enrique, Iloilo (see Annex C).

A total of **P6,903.44** worth of assistance from **DSWD** was provided to the affected family (see Annex D).
