On 26 June 2024 at around 5:00 PM, a fire incident occurred in Brgy. Medina, Madalag, Aklan. The fire was declared out at around 6:00 PM.

## V. Cost of Humanitarian Assistance Provided

A total of ₱12,101.00 worth of assistance was provided to the affected individual; of which, ₱7,751.00 from DSWD and ₱4,350.00 from the Local Government Unit (LGU) (see Annex D).
