## DSWD DROMIC Report on the Fire Incident in Brgy. Olympia, Makati City 29 August 2024, 6AM

### I. Situation Overview

On 06 August 2024 at around 10:47 PM, a fire incident occurred at JB Roxas corner Hormiga St., Brgy. Olympia, Makati City. The fire was declared out at around 11:31 PM.
