

## **DSWD DROMIC Report on the Fire Incident in Brgy. Orong, City of Kabankalan, Negros Occidental**

08 August 2024, 6AM

### **I. Situation Overview**

On 30 July 2024 at around 8:20 AM, a fire incident occurred in Brgy. Orong, City of Kabankalan, Negros Occidental. The fire was declared out at around 9:30 AM.
