

DSWD DROMIC Report on the Fire Incident in Brgy. Outlook Drive, Baguio City

28 August 2024, 6PM

I. Situation Overview

On 08 June 2024 at around 1:00 PM, a fire incident occurred at Purok 3, Brgy. Outlook Drive, Baguio City. The fire was declared out at around 3:00 PM.

II. Status of Affected Areas and Population

A total of **three (3) families** or **five (5) persons** were affected in **Brgy. Outlook Drive, Baguio City** (see Annex A).

III. Status of Displaced Population

a. Inside Evacuation Center

A total of **two (2) families** or **two (2) persons** sought temporary shelter at **Outlook Drive Brgy. Hall** in **Brgy. Outlook Drive, Baguio City** (see Annex B).

b. Outside Evacuation Center

One (1) family or **two (2) persons** temporarily stayed with their relatives or friends (see Annex D).

c. Total Displaced Population

A total of **three (3) families** or **four (4) persons** were displaced in **Outlook Drive Brgy. Hall** (see Annex E).

IV. Damaged Houses

One (1) house was **totally damaged** in **Outlook Drive Brgy. Hall** (see Annex F).

V. Cost of Humanitarian Assistance Provided

A total of **₱55,383.06** worth of assistance was provided to the affected families; of which, **₱30,383.06** from **DSWD** and **₱ 25,000.00** from the **Local Government Unit (LGU)** (see Annex G).
