I. Situation Overview

On 21 July 2024 at around 1:50 PM, a fire incident occurred in Brgy. Pahanocoy, Bacolod City, Negros Occidental. The fire was declared out at around 2:45 PM.

IV. Cost of Humanitarian Assistance Provided

A total of ₱10,692.88 worth of assistance was provided to the affected family; of which, ₱9,192.88 from DSWD and ₱1,500.00 from the Local Government Unit (LGU) (see Annex C).
