## I. Situation Overview

On 04 November 2024 at around 9:35 AM, a fire incident occurred at Sitio Bacung, Brgy. Poblacion, Hungduan, Ifugao. The fire was declared out at around 11:30 AM. Source: DSWD Field Office (FO) CAR

One (1) family or four (4) persons were affected in Brgy. Poblacion, Hungduan, Ifugao (see Annex A).

## IV. Cost of Humanitarian Assistance Provided
