I. Situation Overview

On 18 July 2024 at around 11:43 AM, a fire incident occurred in Brgy. Poblacion, Liloan, Southern Leyte. The fire was declared out at around 12:14 PM.

IV. Cost of Humanitarian Assistance Provided

A total of **₱10,466.00** worth of assistance was provided to the affected family composed of **₱7,966.00** from **DSWD** and **₱2,500** from the **Local Government Unit (LGU)** (see Annex C).
