

## **DSWD DROMIC Report on the Fire Incident in Brgy. San Isidro, Banga, Aklan**

12 August 2024, 6PM

### **I. Situation Overview**

On 26 July 2024 at around 3:20 PM, a fire incident occurred in Brgy. San Isidro, Banga, Aklan. The fire was declared out at around 3:45 PM.

**One (1) family or five (5) persons** are temporarily staying with their relatives or friends (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. San Isidro, Banga, Aklan** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱11,735.44** worth of assistance was provided to the affected family; of which, **₱6,735.44** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
