





# DSWD DROMIC Report on the Fire Incident in Brgy. San Ramon, Bontoc, Southern Leyte

03 August 2024, 6PM

#### I. Situation Overview

On June 21, 2024, at around 6:21 PM, a fire broke out in Barangay San Ramon, Bontoc, Southern Leyte. The fire destroyed one residential house and displaced a family of two who opted to stay with their relatives in the nearby community.

In response, the Department of Social Welfare and Development (DSWD) Field Office in Region VIII, has provided relief assistance to support the immediate needs of the affected family.
