I. Situation Overview

On 01 July 2024 at around 4:00 PM, a fire incident occurred in Brgy. Santo Niño, San Miguel, Iloilo. The fire was declared out at around 5:00 PM.

A total of **P8,401.44** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
