I. Situation Overview

On 17 July 2024 at around 3:30 PM, a fire incident occurred in Brgy. Sum-ag, Bacolod City, Negros Occidental. The fire was declared out at around 4:55 PM.

IV. Cost of Humanitarian Assistance Provided

A total of **₱10,692.88** worth of assistance was provided to the affected family; of which, **₱9,192.88** from **DSWD** and **₱1,500.00** from the **Local Government Unit (LGU)** (see Annex C).
