I. Situation Overview

On 17 July 2024 at around 3:30 PM, a fire incident occurred in Brgy. Sum-ag, Bacolod City, Negros Occidental. The fire was declared out at around 4:55 PM.

One (1) house was partially damaged in Brgy. Sum-ag, Bacolod City, Negros Occidental (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of ₱10,692.88 worth of assistance was provided to the affected family; of which, ₱9,192.88 from DSWD and ₱1,500.00 from the Local Government Unit (LGU) (see Annex C).
