



DSWD DROMIC Report on the Fire Incident in Brgy. Tambunac, San Enrique, Iloilo

30 August 2024, 6AM

I. Situation Overview

On 14 August 2024 at around 2:17 AM, a fire incident occurred in Brgy. Tambunac, San Enrique, Iloilo. The fire was declared out at around 3:00 AM.

II. Status of Affected Areas and Population

One (1) family or six (6) persons were affected in Brgy. Tambunac, San Enrique, Iloilo (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **six (6) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Tambunac, San Enrique, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱16,903.44 worth of assistance was provided to the affected family composed of ₱6,903.44 from DSWD and ₱10,000 from the Local Government Unit (LGU) (see Annex D).
