





DSWD DROMIC Report on the Fire Incident in Brgy. Tangub, Bacolod City

06 August 2024, 6PM

I. Situation Overview

On 04 July 2024 at around 8:30 AM, a fire incident occurred at Brgy. Tangub, Bacolod City. The fire was declared out at around 9:55 AM.

II. Status of Affected Areas and Population

A total of **12 families** or **60 persons** were affected in **Brgy. Tangub, Bacolod City** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **12 families** or **60 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of six (6) houses were damaged; of which, one (1) was totally damaged and five (5) are partially damaged in Brgy. Tangub, Bacolod City (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱129,814.56** worth of assistance was provided to the affected families; of which, **₱110,314.56** from **DSWD** and **₱19,500.00** from the **Local Government Unit (LGU)** (see Annex D).
