### I. Situation Overview

On 10 July 2024 at around 10:30 AM, a fire incident occurred in Fire Incident in Brgy. Taytay, Igaras, Iloilo. The fire was declared out at around 11:00 AM.

A total of **₱12,751.00** worth of assistance was provided to the affected families; of which, **₱7,751.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
