

## **DSWD DROMIC Report on the Fire Incident in Brgy. Tubod, Bingawan, Iloilo**

08 August 2024, 6PM

### **I. Situation Overview**

On 15 July 2024 at around 1:30 PM, a fire incident occurred at Purok 1, Brgy. Tubod, Bingawan, Iloilo. The fire was declared out at around 2:15 PM.
