I. Situation Overview

On 15 July 2024 at around 1:30 PM, a fire incident occurred at Purok 1, Brgy.Tubod, Bingawan, Iloilo. The fire was declared out at around 2:15 PM.

One (1) house was totally damaged in Brgy. Tubod, Bingawan, Iloilo (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱7,919.00 worth of assistance was provided by **DSWD** to the affected family (see Annex D).
