

## DSWD DROMIC Report on the Fire Incident in Brgy. Fulgencio, Balete, Aklan

29 August 2024, 6PM

### I. Situation Overview

On 18 August 2024 at around 11:05 PM, a fire incident occurred at Brgy. Fulgencio, Balete, Aklan. The fire was declared out at around 11:30 PM.

A total of **two (2) families** or **five (5) persons** temporarily staying with their relatives or friends (see Annex B).

### IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1)** is **totally damaged** and **one (1)** is **partially damaged** in **Brgy. Fulgencio, Balete, Aklan** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱12,932.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
