
DSWD DROMIC Report on the Thunderstorm in Brgy. Hilaba, Barugo, Leyte 21 August 2024, 6PM

I. Situation Overview

On July 23, 2024, around 12:30 PM., severe thunderstorms hit Barugo, Leyte, especially affecting Barangay Hilaba. Heavy rain and strong winds caused trees to fall, damaging a house where a family of two lived. The family is now staying with relatives, no injuries or casualties were reported.

In response, the DSWD through its Field Office in Region VIII promptly provided financial and relief assistance to support the immediate needs of the affected family.
