

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Guiguilonen, Mangaldan, Pangasinan

03 August 2024, 6PM

I. Situation Overview

On April 4, 2024, at about 5:20 PM, a fire broke out in a two-storey house in Brgy. Guiguilonen, Mangaldan, Pangasinan. The Bureau of Fire Protection (BFP) reported that only the upper level was affected, causing partial damage. The family is currently residing on the ground level of their house.

In response, the DSWD through its Field Office in Region I, together with the Local Government Unit (LGU) of Mangaldan, Pangasinan, provided financial assistance to support the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or **seven (7) persons** were affected in **Brgy. Guiguilonen, Mangaldan, Pangasinan** (see Annex A).

III. Damaged Houses

One (1) house was **partially** damaged in **Brgy. Guiguilonen, Mangaldan, Pangasinan** (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱15,000.00** worth of assistance was provided to the affected family composed of **₱5,000.00** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex C).
