

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Herrero-Perez, Dagupan City, Pangasinan

03 August 2024, 6PM

I. Situation Overview

On 22 April 2024 at around 3:00 PM, a fire incident occurred in Brgy. Herrero-Perez, Dagupan City, Pangasinan.

In response, the DSWD through its Field Office in Region I, together with the Local Government Unit (LGU) of Dagupan City, Pangasinan, provided relief and financial assistance to support the immediate needs of the affected families.

Moreover, the LGU of Dagupan City, Pangasinan, assumes the management of Internally Displaced Persons (IDPs) and commits to continuously provide interventions as necessary hence, the termination of this report.

II. Status of Affected Areas and Population

A total of **six (6) families** or **15 persons** were affected in **Brgy. Herrero-Perez, Dagupan City, Pangasinan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **six (6) families** or **15 persons** temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

A total of **six (6) houses** were damaged; of which, **three (3)** are **totally damaged** and **three (3)** are **partially damaged** in **Brgy. Herrero-Perez, Dagupan City, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱69,081.60** worth of assistance was provided to the affected families composed of **₱63,081.60** from **DSWD** and **₱6,000.00** from the **Local Government Unit (LGU)** (see Annex D).
