

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Mansaya-Lapuz, Iloilo City

12 January 2025, 6PM

I. Situation Overview

On 31 July 2024 at around 7:35 AM, a fire incident occurred in Brgy. Mansaya-Lapuz, Iloilo City. The fire was declared out at around 8:16 AM.

In response to the incident, the Department of Social Welfare and Development (DSWD), through its Field Office in Region VI, in coordination with the Local Government Unit (LGU) of Iloilo City, provided relief assistance in the form of food and non-food items to support the immediate needs of the affected families and individuals.

II. Status of Affected Areas and Population

A total of 11 families or 32 persons were affected in Brgy. Mansaya-Lapuz, Iloilo City (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of 11 families or 32 persons sought temporary shelter in Bo. Obrero National High School in Brgy. Mansaya-Lapuz, Iloilo City (see Annex B).

IV. Damaged Houses

A total of **four (4) houses** were **totally damaged** in **Brgy. Mansaya-Lapuz, Iloilo City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of \$\frac{P}265,721.00\$ worth of assistance was provided to the affected families composed of \$\frac{P}87,604.00\$ from DSWD and \$\frac{P}178,117.00\$ from the Local Government Unit (LGU) (see Annex D).
