

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Pudoc East, Tagudin, Ilocos Sur

21 September 2024, 6PM

## I. Situation Overview

On 11 August 2024 at around 4:00 PM, a fire incident occurred in Brgy. Pudoc East, Tagudin, Ilocos Sur.

In response, the DSWD through its Field Office in Region I, together with the Local Government Unit (LGU) of Tagudin, Ilocos Sur, provided relief and financial assistance to support the immediate needs of the affected family.

**One (1) house** was **totally damaged** in **Brgy. Pudoc East, Tagudin, Ilocos Sur** (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of **₱28,803.20** worth of assistance was provided to the affected family composed of **₱18,803.20** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
