

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Rogongon, Iligan City, Lanao del Norte

14 August 2024, 6AM

## I. Situation Overview

On 22 June 2024 at around 10:00 PM, a fire incident occurred at Purok 1, Santa Cruz, Brgy. Rogongon, Iligan City, Lanao del Norte. The fire was declared out at around 10:30 PM.

A total of **₱11,698.00** worth of assistance was provided to the affected families composed of **₱5,698.00** from **DSWD** and **₱6,000.00** from the **Local Government Unit (LGU)** (see Annex D).
