



DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Tubod, Iligan City, Lanao del Norte

14 August 2024, 6AM

I. Situation Overview

On 03 July 2024 at around 6:15 PM, a fire incident occurred at Purok Coca-Cola, Brgy. Tubod, Iligan City, Lanao del Norte. The fire was declared out at around 6:35 PM. Source: DSWD Field Office (FO) X

II. Status of Affected Areas and Population

A total of six (6) families or 33 persons were affected in Brgy. Tubod, Iligan City, Lanao del Norte (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **six (6) families** or **33 persons** sought temporary shelter at the **Brgy. Tubod Hall** in **Iligan City, Lanao del Norte** (see Annex B).

IV. Damaged Houses

A total of **four (4) houses** were damaged; of which, **two (2)** are **totally damaged** and **two (2)** are **partially damaged** in **Brgy. Tubod, Iligan City, Lanao del Norte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱56,736.00 worth of assistance was provided to the affected families composed of ₱50,736.00 from DSWD and ₱6,000.00 from the Local Government Unit (LGU) (see Annex D).
