I. Situation Overview

On 07 August 2024 at around 11:00 PM, a fire incident occurred at Purok 1, Brgy. Tabigue, Kolambugan, Lanao del Norte. The fire was declared out at around 11:36 PM.

Two (2) families or **four (4) persons** were affected in **Brgy. Tabigue, Kolambugan, Lanao del Norte** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

Two (2) families or **four (4) persons** still staying with their relatives (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1)** are **totally damaged** and **one (1)** are **partially damaged** in **Brgy. Tabigue, Kolambugan, Lanao del Norte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱22,472.00** worth of assistance was provided to the affected families composed of **₱16,472.00** from **DSWD** and **₱6,000.00** from the **Local Government Unit (LGU)** (see Annex D).
