





DSWD DROMIC Terminal Report on the Strong Wind Incident in President Quirino, Sultan Kudarat

21 September 2024, 6PM

I. Situation Overview

On 17 August 2024, a strong wind incident occurred in several barangays in President Quirino, Sultan Kudarat.

In response, the DSWD through its Field Office in Region XII, together with the Local Government Unit of President Quirino, Sultan Kudarat, provided relief assistance to support the immediate needs of the affected populace. Moreover, the LGU has taken full responsibility for managing the needs of the displaced individuals and has committed to ongoing support and interventions as required. Hence, the termination of this report.

II. Status of Affected Areas and Population

A total of **140 families** or **452 persons** were affected in **five (5) barangays** in **President Quirino, Sultan Kudarat** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are **17 families** or **85 persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **140 houses** were damaged; of which, **17** are **totally damaged** and **123** are **partially damaged** in **President Quirino**, **Sultan Kudarat** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱321,928.00 worth of assistance was provided to the affected families composed of ₱202,928.00 from DSWD and ₱119,000.00 from the Local Government Unit (LGU) (see Annex D).
