





## DSWD DROMIC Terminal Report on the Vehicular Incident in Brgy. Ayaga, Abulug, Cagayan

03 August 2024, 6PM

## I. Situation Overview

On 11 July 2024 at around 12:00 AM, a vehicular incident occurred along the National Highway, Brgy. Ayaga, Abulog, Cagayan that resulted in several casualties.

Relative to the incident, the DSWD through its Field Office in Region II, together with the Local Government Unit (LGU) of Abulug, Cagayan, provided relief and financial assistance to support the immediate needs of the affected individuals.
