

DSWD DROMIC Report #1 on the Fire Incident in Brgy. Ketegan, Bautista, Pangasinan as of 12 September 2024, 6PM

I. Situation Overview

On 26 August 2024 at around 1:21 PM, a fire incident occurred in Brgy. Ketegan, Bautista, Pangasinan.

II. Status of Affected Areas and Population

Two (2) families or **seven (7) persons** are affected in **Brgy. Ketegan, Bautista, Pangasinan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are **two (2) families** or **seven (7) persons** temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

Two (2) houses were **totally damaged** in **Brgy. Ketegan, Bautista, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱35,475.20** worth of assistance was provided to the affected families; of which, **₱25,475.20** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
