I. Situation Overview

On 07 September 2024 at around 6:00 PM, a fire incident occurred at Purok 1 Sitio Bangngao, Brgy. Sacpil, Conner, Apayao. The fire was declared out at around 8:00 PM.

One (1) family or four (4) persons temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Sacpil, Conner, Apayao (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P9,437.50** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
