I. Situation Overview

On 10 September 2024 at around 2:20 AM, a fire incident occurred in Brgy. Tetuan, Zamboanga City. The fire was declared out at around 6:23 AM.

A total of **33 families** or **99 persons** are affected in **Brgy. Tetuan, Zamboanga City** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are **33 families** or **99 persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of 15 houses were totally damaged in Brgy. Tetuan, Zamboanga City (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P87,340.00** worth of assistance was provided by the **DSWD** to the affected families (see Annex D).
