## DSWD DROMIC Report #48 on Kanlaon Volcano Eruption as of 17 September 2024, 6PM

### I. Situation Overview

As of **15 September 2024**, **Alert Level 2** is maintained over Kanlaon Volcano.

On 03 June 2024 at 8:00 PM, Alert Level 2 was raised from Alert Level 1 for Kanlaon Volcano after a moderately explosive eruption occurred at the summit crater. On 08 June, 28 June, 02 July, 03 July, 15 July, 10 August, 13 August, 21 August, 24 August, 25 August, 09 September, 10 September, and 11 September 2024, observations of increased seismic activity, increased ground deformation changes, and elevated volcanic sulfur dioxide gas flux were recorded over the Kanlaon Volcano.

The public is reminded that **Alert Level 2 (increasing unrest) prevails over Kanlaon**. This means that there is current unrest may lead to eruptive unrest and an increase in the Alert Level.

The public is strongly advised to be vigilant and avoid entry into the four (4) kilometer-radius Permanent Danger Zone (PDZ) to minimize risks from volcanic hazards such as pyroclastic density currents, ballistic projectiles, rockfall and others. In case of ash fall events that may affect communities downwind of Kanlaon's crater, people should cover their nose and mouth with a damp, clean cloth or dust mask.

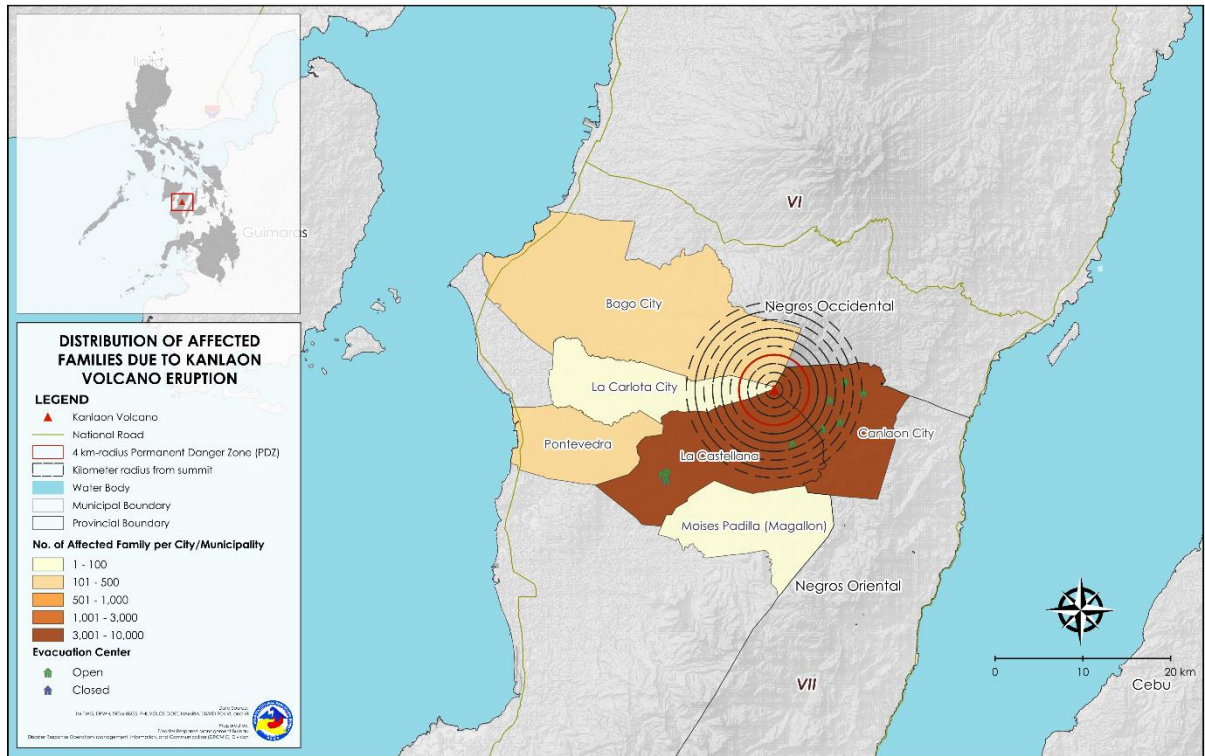
Civil aviation authorities must also advise pilots to avoid flying close to the volcano's summit as ash and ballistic fragments from sudden eruption can be hazardous to aircraft.

Communities living beside river systems on the southern and western slopes, especially those that have already experienced lahars and muddy stream flows, are advised to take precautionary measures when heavy rainfall over the volcano has been forecast or has begun.

### II. Status of Affected Areas and Population

A total of **17,279 families** or **57,226 persons** are affected in **23 barangays** in **Regions VI and VII** (see Annex A).



### III. Status of Displaced Population

#### a. Inside Evacuation Center

There are **1,039 families** or **3,223 persons** currently taking temporary shelter in **11 evacuation centers** in **Regions VI** and **VII** (see Annex B).

#### b. Outside Evacuation Center

A total of **212 families** or **775 persons** temporarily stayed with their relatives or friends (see Annex E).

#### c. Total Displaced Population

There are **1,039 families** or **3,223 persons** displaced in **Regions VI** and **VII** (see Annex F).

### IV. Damaged Houses

A total of **2,680 houses** were **partially damaged** in **La Castellana, Negros Occidental, Region VI** (see Annex G).

### V. Cost of Humanitarian Assistance Provided

A total of **₱54,720,043.67** worth of assistance was provided to the affected families composed of **₱37,919,880.28** from the **DSWD**, **₱4,414,412.97** from the **Local Government Units (LGUs)**, **₱2,491,000.00** from **Non-Government Organizations (NGOs)** and **₱9,894,750.42** from **Other Partners** (see Annex H).
