I. Situation Overview

On 14 August 2024 at around 1:30 PM, a fire incident occurred in Brgy. 23 (Poblacion), Bacolod City, Negros Occidental. The fire was declared out at around 2:15 PM.

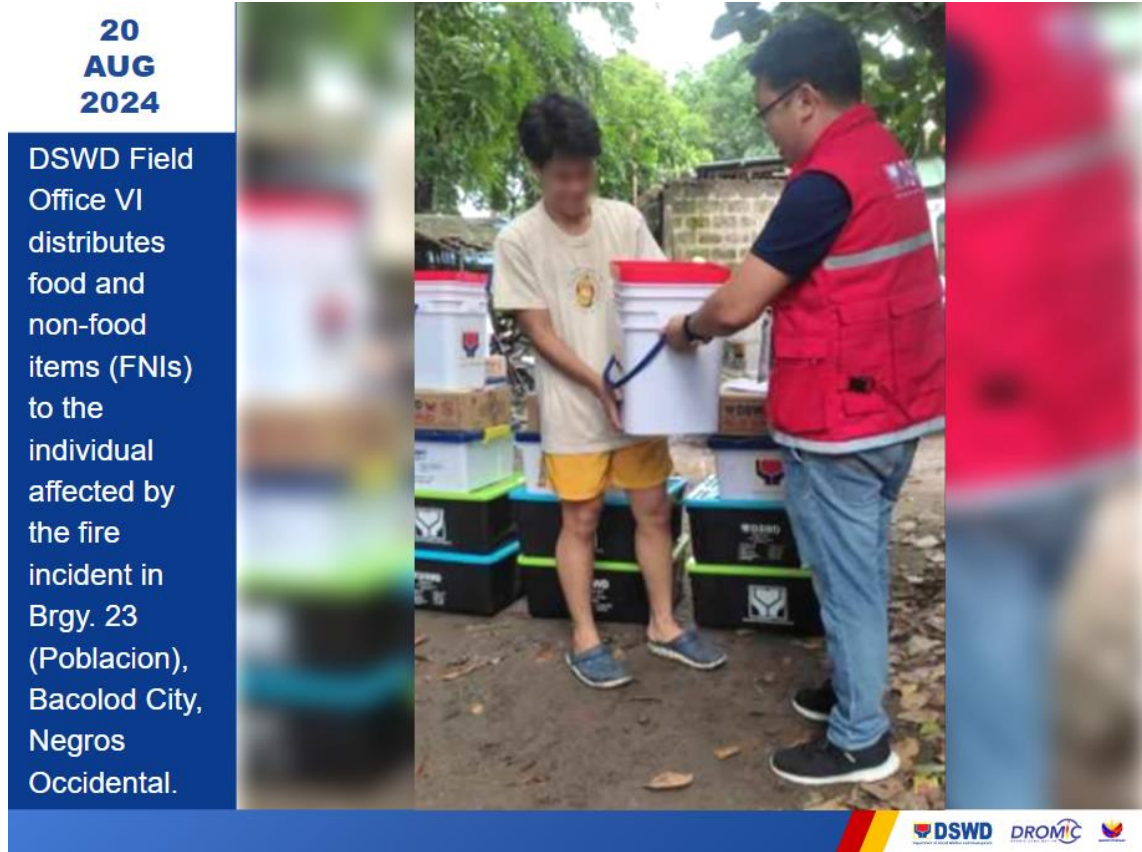
