I. Situation Overview

On 07 September 2024 at around 9:00 PM, a fire incident occurred in Brgy. Balusbos, Malay, Aklan. The fire was declared out at around 9:45 PM.

Outside Evacuation Center

One (1) family or three (3) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Balusbos, Malay, Aklan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱6,788.00** worth of assistance was provided to the affected family; of which, **₱5,588.00** from **DSWD** and **₱1,200.00** from the **Local Government Unit (LGU)** (see Annex D).
