I. Situation Overview

On 21 August 2024 at around 5:30 PM, a fire incident occurred in Brgy. Buaya, Carles, Iloilo. The fire was declared out at around 5:50 PM.

V. Cost of Humanitarian Assistance Provided

A total of **P4,175.44** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
