I. Situation Overview

On 14 September 2024 at around 10:30 PM, a fire incident occurred at Cacao St., Brgy. Coral, Mapandan, Pangasinan.

IV. Cost of Humanitarian Assistance Provided

A total of **P25,692.70** worth of assistance was provided to the affected families; of which, **P17,692.70** from **DSWD** and **P8,000.00** from the **Local Government Unit (LGU)** (see Annex C).
