04 September 2024, 6AM

I. Situation Overview

On 22 August 2024 at around 9:00 PM, a fire incident occurred at Brgy. Lucero, Jamindan, Capiz. The fire was declared out at around 10:10 PM.

One (1) family or **five (5) persons** were affected in **Brgy. Lucero, Jamindan, Capiz** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center One (1) family or five (5) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) was totally damaged in Brgy. Lucero, Jamindan, Capiz (see Annex C).

v. Cost of Humanitarian Assistance Provided

A total of **P11,735.44** worth of assistance was provided to the affected families; of which, **P6,735.44** from **DSWD** and **P5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
