

DSWD DROMIC Report on the Fire Incident in Brgy. Lucero, Jamindan, Capiz

04 September 2024, 6AM

I. Situation Overview

On 22 August 2024 at around 9:00 PM, a fire incident occurred at Brgy. Lucero, Jamindan, Capiz. The fire was declared out at around 10:10 PM.

One (1) family or **five (5) persons** were affected in **Brgy. Lucero, Jamindan, Capiz** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **five (5) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) was **totally damaged** in **Brgy. Lucero, Jamindan, Capiz** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱11,735.44** worth of assistance was provided to the affected families; of which, **₱6,735.44** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).

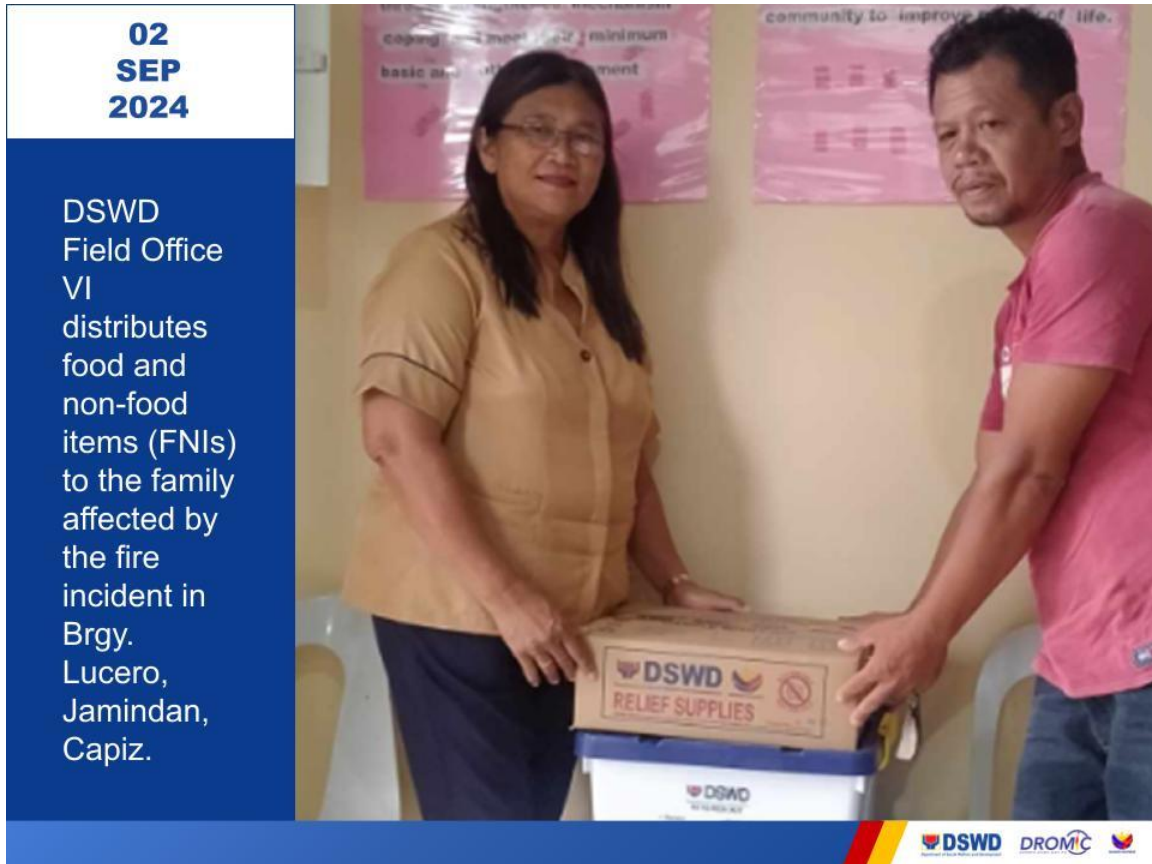
