I. Situation Overview

On 07 September 2024 at around 6:23 PM, a fire incident occurred in Brgy. Pias, Mapandan, Pangasinan.

One (1) family or five (5) persons were affected in **Brgy. Pias, Mapandan, Pangasinan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or five (5) persons are temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

One house was **totally damaged** in **Brgy. Pias, Mapandan, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱25,692.70** worth of assistance was provided to the affected families; of which, **₱22,692.70** from **DSWD** and **₱3,000.00** from the **Local Government Unit (LGU)** (see Annex D).
