I. Situation Overview

On 29 July 2024 at around 11:45 AM, a fire incident occurred at M. Reyes corner Arguelles St., Brgy. Pio Del Pilar, Makati City. The fire was declared out at around 12:16 PM.

17 families or **45 persons** temporarily stayed with their relatives and friends (see Annex B).

Four (4) houses were totally damaged in Brgy. Pio Del Pilar, Makati City (see Annex C).
