

DSWD DROMIC Report on the Fire Incident in Brgy. Taculing, Bacolod City

09 September 2024, 6PM

I. Situation Overview

On 08 August 2024 at around 2:30 PM, a fire incident occurred in Brgy. Taculing, Bacolod City. According to the Bureau of Fire Protection (BFP), the fire caused was allegedly due to faulty electrical wirings and it was declared out at around 3:15 PM.

In response, the DSWD through its Field Office in Region VI together with the Local Government Unit (LGU) of Bacolod City, promptly provided relief assistance to support the immediate needs of the affected families.

A total of **two (2) families** or **four (4) persons** were affected in **Brgy. Taculing, Bacolod City** (see Annex A).

A total of **two (2) families** or **four (4) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Taculing, Bacolod City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱18,066.88** worth of assistance was provided to the affected families composed of **₱16,066.88** from **DSWD** and **₱2,000.00** from the **Local Government Unit (LGU)** (see Annex D).
