11 September 2024, 6AM

I. Situation Overview

On 21 August 2024 at around 2:25 PM, a fire incident occurred in Brgy. Tangub, Bacolod City, Negros Occidental. The fire was declared out at around 3:45 PM.

A total of **eight (8) families** or **41 persons** were affected in **Brgy. Tangub, Bacolod City, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **eight (8) families** or **41 persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

A total of **six (6) houses** were **totally damaged** in **Brgy. Tangub, Bacolod City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱91,363.52** worth of assistance was provided to the affected families; of which, **₱64,363.52** from **DSWD** and **₱27,000.00** from the **Local Government Unit (LGU)** (see Annex D).
